The president leads the executive branch of the federal government, the branch of government that is responsible for making sure that laws are carried out. The president's other duties include appointing the heads of cabinets and judges to the Supreme Court. Finally, the president is also the commander-in-chief of the US Armed Forces. Congress reserves the right to declare war, but the president has the final say in military plans.

According to the passage, FDR "served as president from March 4, 1933 to April 12, 1945...three full 4-year terms," dying three months into his "fourth term." Details like "served as president," "from March 4, 1933 to April 12, 1945" and "4-year" show that in this passage, "term" means "the length of time during which something happens." Here, it refers to the length of time that a president is elected for.

6. On August 9, 1974, Richard Nixon became the only president to resign. He was facing impeachment and removal from office following a political scandal. After Nixon's resignation, Vice President Gerald Ford automatically took over as president without being elected. Ford had not been Nixon's original vice president. He took over as vice president when Spiro T. Agnew resigned from office over charges unrelated to Nixon's scandal. Nixon used the power of the 25th Amendment to make Ford the new vice president.

These details show that Ford took over both the vice presidency and the presidency through means other than a national election.

7. Although our first president, George Washington, selected the site for the White House in 1791, he wasn't the first to live there. The distinction of being the first White House ^^resident^^ goes to our second president, John Adams. After eight years of construction, Adams and his wife Abigail moved into the unfinished house in 1800. The residence was designed by an Irish-born architect and built mostly by enslaved African Americans. It was rebuilt after a British attack in 1814 and later underwent technological changes, like the addition of electricity.



It set up online health insurance marketplaces where people could buy insurance plans. During his presidency, Obama also worked to restore a relationship with Cuba. For the previous 54 years, the US did not have a strong relationship with Cuba due to Cuba's allegiance in the Cold War. Obama got rid of some restrictions on trade and travel between the US and Cuba.
