Political Debates - Answer Key

Use the text to answer each question below.

1. The word “democracy” comes from Greek and means, roughly, “people power.” In a democracy, the citizens have a voice in how the government is run. Sometimes, this takes the form of direct democracy. That’s when citizens vote on actual decisions. In the US, there are some examples of direct democracy. A local election might include a measure that asks citizens if they support the city investing in a new bike path. If the majority of votes support the proposition, it passes. If not, it fails.

More often, elections in the US are examples of representative democracy. That’s when citizens don’t make decisions directly but instead vote for a candidate they believe will make decisions in accordance with their beliefs.

2. In the US, the presidential election occurs in two phases: a primary election and a general election. In the primary election, the two main parties—Republican and Democrat—pick one candidate each to be their nominee. States have primary elections or caucuses at different times. In the general election, the winners of the primary compete against each other. The general election is held on the first Tuesday in November.

In 2019, over 20 Democratic candidates are running in the primary to become the Democratic nominee in the 2020 presidential election. In April 2019, former Massachusetts governor Bill Weld announced that he was running as a Republican against incumbent, or current, Republican President Donald Trump.
