## Veterans Day - Answer Key

Use the text to answer each question below.

1. World War I (WWI) took place in Europe from 1914 to 1918. The United States and countries like Great Britain and France fought against Germany and other countries. During the mid-1900s, WWI was called the Great War. At the time, no one knew that there would be another world war. New technologies like machine guns, tanks and chemical weapons were first used during WWI. More than 9 million soldiers were killed, and 21 million were hurt. Woodrow Wilson, the US president at the time, referred to WWI as "the war to end all wars." It was such a big, destructive war that he thought it would be the last one.

Which detail from the passage best supports the statement that World War I was a very destructive war?

At 11 o'clock on November 11, 1918, the two sides fighting in WWI signed an armistice. In this case, the fighting did not start again. The war ended officially in June 1919.

About 70 million people died as a result of the war. After WWII, veteran service groups urged Congress to change the name of Armistice Day to Veterans Day. They felt that Armistice Day left people out. They wanted a holiday that honored all veterans from every war. In 1954, Congress changed the name of Armistice Day to Veterans Day. President Eisenhower signed the act that made it a holiday. Since then, Veterans Day has been a day to honor all American veterans for their patriotism, service and sacrifice.
